
Subject: LTjg Wallace - memorial seat inquiry

Greetings from Annapolis! On behalf of our President/CEO George Watt, I write in response to your inquiry regarding a memorial seat in memory of your late husband, LTjg Richard C. Wallace. I confirm that there is a seat designated in his memory at Navy-Marine Corps Memorial Stadium in Annapolis.

Attached please find a photo, taken very recently by our staff, of the seat plate at the Stadium. The location of the seat is: <u>Section 28, Row 11, Seat 22.</u>

The Naval Academy has completed the renovation of the Stadium, with a rededication taking place in the Fall of 2005. As its name implies, we believe that this facility is truly a memorial that happens to be a stadium and that it honors appropriately those who have served our Nation in uniform.

Special Extra Earnings For Military Service



Under certain circumstances, special extra earnings for your military service from 1940 through 2001 can be credited to your record for Social Security purposes. These extra earnings may help you qualify for Social Security or increase the amount of your Social Security benefit.

Special extra earnings are granted for periods of active duty or active duty for training. Special extra earnings are not granted for inactive duty training.

Note: If your active military service occurred

- After 1967, you do not need to do anything to receive these extra credits. The credits were automatically added to your record
- In 1967 or earlier, we will add the credits to your record when you apply for Social Security benefits

How You Get Credit For Special Extra Earnings

The information that follows applies only to active duty military service earnings from 1940 through 2001. Here's how the special extra earnings are credited:

- Service In 1978 through 2001- For every \$300 in active duty basic pay, you are credited with an additional \$100 in earnings up to a maximum of \$1,200 a year. If you enlisted after September 7, 1980, and didn't complete at least 24 months of active duty or your full tour, you may not be able to receive the additional earnings. Check with Social Security for details.
- Service In 1957 Through 1977- You are credited with \$300 in additional earnings for each calendar quarter in which you received active duty basic pay.
- Service In 1940 Through 1956- If you were in the military during this period, including attendance at a service academy, you did not pay Social Security taxes. However, your Social Security record may be credited with \$160 a month in earnings for military service from September 16, 1940, through December 31, 1956, under the following circumstances:
 - You were honorably discharged after 90 or more days of service;
 - or, you were released because of a disability or injury received in the line of duty;
 - or, You are still on active duty;
 - o or, You are applying for survivors benefits and the veteran died while on active duty.

You cannot receive credit for these special extra earnings if you are already receiving a federal benefit based on the same years of service. There is one exception: If you were on active duty after 1956, you can still get the special earnings for 1951 through 1956, even if you're receiving a military retirement based on service during that period.

Membership Notes From the Secretary/Treasurer:

Since Jan. 1st through [March 2, 2007] we have 545 members who have paid dues for 2007. Several have renewed for more than 1 year. With multi-year renewals from previous years we have 586 current members.

Of the 545 members 51 were AWOL during the previous 1 to 5 years. (9.4%)

Eleven new members have joined since Jan. 1, 2007.

The AWOL list numbers 142. 137 of these we have not heard from since 2003 or earlier. At least 25 of the 144 have moved with no forwarding address. Seven members have notified me that they have resigned from SBSA or asked to have their membership cancelled or refused to renew membership. That is about 1.2% of the current membership and renewals are still coming in almost every day [as of March 2, 2007].

Last Patrol Notice

BMC William T. (Tommy) Langham, USNR, Ret. died on January 12, 2007, in Beaumont, Texas, at the age of 79. He was an active member of SBSA. Chief Langham served over 30 years in the Reserves and had active duty tours in both Korea and Vietnam. In Korea, he served aboard the USS Blue (DD-387).

For both tours in Vietnam, he volunteered to go back on active duty for the specific assignment. His first tour was as the Boatswain's Mate on PCF-18 in Chu Lai and his second tour was with the Riverine Forces in the Mekong Delta where he received the Purple Heart. Subsequently, he was a member of Special Boat Unit 22, a reserve unit based at the Pearl River in Louisiana. (Those who attended our New Orleans reunion may remember the outstanding boat operations demonstration conducted by members of that unit.) Chief Langham was a PBR Captain and was in charge of training. He served on a number of training missions to several Central and South American countries, including Panama, Honduras, and Colombia.

Military honors for his funeral service, conducted by a military association of retired veterans, were very impressive, and were concluded by the placing of three spent cartridges, representing Duty, Honor, and Country, in the folded flag presented to his family. The writer, as his former OINC, was privileged to serve as a pall bearer. Also present was SBSA President Raul Herrera and his wife, Luz. Rest in peace, "Boats."







VA Reaches Out to Veterans and Spouses "Aid and Attendance" an Under-Used Benefit

WASHINGTON (Dec. 19, 2006) - The Department of Veterans Affairs (VA) is reaching out to inform wartime veterans and surviving spouses of deceased wartime veterans about an under-used, special monthly pension benefit called Aid and Attendance.

"Veterans have earned this benefit by their service to our nation," said Secretary of Veterans Affairs Jim Nicholson. "We want to ensure that every veteran or surviving spouse who qualifies has the chance to apply."

Although this is not a new program, not everyone is aware of his or her potential eligibility. The Aid and Attendance pension benefit may be available to wartime veterans and surviving spouses who have in-home care or who live in nursing-homes or assisted-living facilities.

Many elderly veterans and surviving spouses whose incomes are above the congressionally mandated legal limit for a VA pension may still be eligible for the special monthly Aid and Attendance benefit if they have large medical expenses, including nursing home expenses, for which they do not receive reimbursement.

To qualify, claimants must be incapable of self support and in need of regular personal assistance.

The basic criteria for the Aid and Attendance benefit include the inability to feed oneself, to dress and undress without assistance, or to take care of one's own bodily needs. People who are bedridden or need help to adjust special prosthetic or orthopedic devices may also be eligible, as well as those who have a physical or mental injury or illness that requires regular assistance to protect them from hazards or dangers in their daily environment.

For a wartime veteran or surviving spouse to qualify for this special monthly pension, the veteran must have served at least 90 days of active military service, one day of which was during a period of war, and be discharged under conditions other than dishonorable.

Wartime veterans who entered active duty on or after September 8, 1980, (October 16, 1981, for officers) must have completed at least 24 continuous months of military service or the period for which they were ordered to active duty.

If all requirements are met, VA determines eligibility for the Aid and Attendance benefit by adjusting for un-reimbursed medical expenses from the veteran's or surviving spouse's total household income. If the remaining income amount falls below the annual income threshold for the Aid and Attendance benefit, VA pays the difference between the claimant's household income and the Aid and Attendance threshold.

The Aid and Attendance income threshold for a veteran without dependents is now \$18,234 annually. The threshold increases to \$21,615 if a veteran has one dependent, and by \$1,866 for each additional dependent. The annual Aid and Attendance threshold for a surviving spouse alone is \$11,715. This threshold increases to \$13,976 if there is one dependent child, and by \$1,866 for each additional child.

Navy's Riverine Force Leaves On Its First Deployment To Iraq

VIRGINIA BEACH - Corpsman Kyle Bailey loaded his gear aboard a bus Thursday morning at Little Creek Naval Amphibious Base, leaving for his second combat mission to Iraq.

Bailey went over with a Seabees unit in 2003 but, he said, "a lot of things are different now." This time, Bailey joins 120 sailors from a new unit, Riverine Squadron 1, with a new Navy mission to patrol Iraqi waterways. Before he boarded the bus, Bailey repeated advice from recent combat vets about Iraq: "Don't get lazy."

The riverine sailors will join a Marine Corps unit patrolling the Euphrates River. It marks the first time an active-duty Navy riverine unit has deployed since the

Vietnam War more than 30 years ago.

The new generation of brown-water sailors will work side by side with the Marines to provide maritime security. Eventually, the Navy will take over the task, patrolling in 30-foot fast boats with crews of four or five sailors.

At their Little Creek home base on Thursday, sailors huddled against frigid early morning winds and said final good-byes before their long flight.

Petty Officer 3rd Class Nicholas Waters cradled his 3-month-old son, Nicholas V, and waited to leave. The 30-year-old Texas native joined the riverine squadron shortly after the squadron formed last year because, he said, "it was the way the Navy was going."

Waters deployed earlier to the Middle East, but the master at arms expects to be closer to combat during this mission. His wife, Rachael, gave him a simple command. "I just want him to be strong," she said, and "stay alive."

The sailors were the second of three groups from Riverine Squadron 1 to deploy. About 60 sailors assigned to logistics support arrived in Iraq last month, and another 50 sailors will follow in the coming months.

Cmdr. Bill Guarini, the squadron's commanding officer, said the deployment continues the Navy's historic mission: maintaining safe seas and waterways.

The squadron leaned heavily on the advice of Vietnam veterans, known as river rats, for advice on equipment, training and tactics, he said.

The new river rats will have more advanced equipment, however, including unmanned aerial vehicles, infrared sensors and other electronic, data-gathering devices, he said

"Little expense has been spared," Guarini said.

He added that the Marines' mission has been relatively safe. So far, insurgents have not been planting deadly improvised explosive devices along the waterways.

Petty Officer 3rd Class Joshua Lipstein joined the Navy 15 months ago, straight from high school. So far, the 19-year-old has loved his training and he said he is ready for a real mission. Lipstein has been assigned to perform camp security. His nervous parents in Delaware offered advice: "Be safe. Be aware of what's around you."

from time-to-time just how a group like ours got itself formed. I decided to try to make some sense of this and contacted a number of guys who I knew had a direct part in putting together various parts of the organization we now call the Swift Boat Sailors Association.

interested in joining a new group called the Swift Officers Association (SOA). It was run by a former OinC in State College, PA, and had a mailing list and newsletter. Unfortunately, it didn't survive and the treasury was donated to a new project being constructed on the Mall in Washington, DC; The Vietnam Memorial. So Swifties had a part in funding the most visited site in Washington!

There followed a hiatus of nearly twenty years with little or no activity of Meanwhile, there was furious activity in electing the first officers of the leader of the MRFA, that several Swifties were extended memberships was the first contact they'd had with crew mates and other Swifties since leaving Vietnam. These early veterans' get-togethers with MRFA and Gamewardens also put together the right people to make something wonderful possible.

Fortunately, during that period many other shipmates also stayed in touch with each other. One of these shipmates was the guy to whom we all owe our memberships: <u>Joseph "Doc" Quartuccio</u>. Retired Navy Thoi, RVN. Starting in December of 1994, Doc planned a get-together in Scottsboro, AZ, on Memorial Day in 1995. Doc contacted Wey Symmes and got him and Jim Thomas together to work on formalizing an organization. In December 1994 Wey and his wife, Terry, put out what would become the first ever newsletter, "Attention: Swift Boat Sailors" Jim Thomas took on a very large part of the early responsibilities: setting the first who responded to the enclosed questionnaire! Twenty-one Swifties attended and, along with a bunch of sea stories, they cobbled together a charter which first approved the name, Swift Boat Sailors Association. Jim Thomas, who later became the first President of the SBSA, wrote this charter and the Swifties present approved it and agreed to form an organization.

two PCFs were discovered in Panama in a warehouse. When it was replica of the Coastal Division One pin we all wore in-country. sure they could be available, Wey Symmes contacted Gary Blinn to exchange names and addresses so as many as possible could be notified of this second get-together to be held in Washington, DC, when PCF-1 was to be dedicated to the Navy Museum on June 17, 1995 (in the Washington Navy Yard). Wey and Terry published another newsletter in March 1995 advising the growing mailing list of this new development. Bill Lannom and his company were busily making the original fic organization that is one of the most respected veterans' organizations "Swift Boats - Vietnam" ball caps and Larry Wasikowski took on the around. From these humble beginnings we now have a solid financial project of ordering golf shirts for attendees. PCF-2, discovered along with the "1 boat" was later donated to Tidewater Community College in Norfolk, VA. Both boats were made sea-worthy in the Norfolk area and then driven to the Navy Yard in what was to become "The Last River Run". This get-together was quite a bit larger than the Scottsboro meeting with several hundred Swifties and families showing up. Rides on PCFs 1 & 2 were featured, a visit to the Marine Corps 8th & I Silent Drill Team was scheduled, there were cocktails hosted by Congressman Jim Colby, and the usual Navy speeches of acceptance and recognizing the

Most "Swifties" who are members of the SBSA have probably wondered efforts of all concerned. Admiral Zumwalt gave a memorable talk in which he noted that he didn't own a set of tropical whites any longer, explaining why he was in Blues in spite of the heat of Washington. Senator Kerry gave a superb speech which left not a dry eye in the crowd. That Saturday evening started the tradition of the Swift banquet with open mike session afterwards. I was privileged to attend this affair and to this day it remains one of the most memorable events of my life: seeing shipmates who I hadn't seen in over 30 years and riding those magnificent boats one more time (even though it was driven by a guy young enough to have been my son!).

a formal nature between Swifties. I've learned from Albert Owens, newly formed group: Jim Thomas as President, Harry Creamer as VP, Ed Munday as Secretary, and Wey Symmes as Treasurer. Wey and in that organization during this period. For several, like Wey Symmes, it Terry Symmes became the *de facto* Membership Committee, the Ship's Store operators, and assisted Gary Blinn in sorting the membership lists so more Swifties could be recruited.

Thanks to Wey and Terry Symmes, the association was incorporated in Montana on August 25, 1995. In January of 1996 the association was approved as a Veterans Organization by the IRS with the name "Swiftboat [SIC] Sailors Association" (this "edit" was later corrected). Keep in mind that all this paperwork was done by a very few people in a Corpsman Doc was a plank-owner of the first Swift Boat Division at An very short time! Volunteer labor and mooching from friends and acquaintances was then, and remains, the order of the day! Terry Symmes was also convinced by Jim Thomas to become the official newsletter editor – do we see a trend here with Terry?

with a mailing list of fifty names. Fittingly, Admiral Zumwalt was among up the first newsletters, planning the first "official" reunion in San Diego in 1996, and getting the membership cards. By-Laws (which now supersede the early charter and purpose statements) had to be written by a friendly attorney and a board of directors formed. Jerry Leeds, in Gerard, KS, was instrumental in setting up the membership cards with Jim. He thought Jim's design was a bit "in your face" but liked it - you have one in your wallet right now! Jim also traveled to Grinnell, IA, to work with Bill Lannom on hats and jackets.
