Through a travesty of errors and irresponsible actions by the modeler, the delivery of Rob's PCF was never completed as promised. We were determined to make things right and Miniature Dream Models, Inc. made it happen. At last contact, Ken Bolen indicated that the glass case would be shipped next.

The PCF model history behind Miniature Dream Models, Inc. is most interesting as well as ironic. It was the late Buddy Berman QM2, PCF-5 that had contacted Ken and Carrie in hopes that they would attend a model of a Coast Guard rescue boat that Ken produced at the time. Veterans, Servicemembers Not In Uniform May Now Salute Flag

8/14/2007 - WASHINGTON, D.C. -- U.S. Senator Jim Inhofe (R-Okla.) today praised the passage by unanimous consent of his bill (S.1877) clarifying U.S. law to allow veterans and service personnel not in uniform to salute the flag.

Current law (US Code Title 4, Chapter 1) states that veterans and service members not in uniform should place their hand over their heart without clarifying whether they can or should salute the flag.

"The salute is a form of honor and respect, representing pride in one's military service." Senator Inhofe said. "Veterans and service members continue representing the military services even when not in uniform. "Unfortunately, current U.S. law leaves confusion as to whether veterans and service members out of uniform can or should salute the flag. My legislation will clarify this regulation, allowing veterans and service personnel alike to salute the flag, whether they are in uniform or not."

"I look forward to seeing those who have served saluting proudly at baseball games parades, and formal events. I believe this is an appropriate way to honor and recognize the 25 million veterans in the United States who have served in the military and remain as role models to others citizens. Those who are currently serving or have served in the military have earned this right, and their recognition will be an inspiration to others."

Since then the Foundation has awarded nearly 2 ¼ million dollars in grants to over 300 severely wounded combat veterans of Iraq and Afghanistan. The Foundation has contributed 50 thousand dollars to the Vietnam Unit Memorial Monument Fund to honor and perpetuate the memory of our fallen shipmates who gave their last full measure of devotion to their Country in the Vietnam War.

It would be impossible to assist our wounded military personnel without the assistance of numerous Swifties located across our great country. Every Swiftie we've contacted to present a grant has volunteered to personally present the award letter and check with a hearty handshake to each of our recipients. Our Foundation's policy is that each of our grants be presented by a Swift Boat Sailor. The Swifties who have assisted us in this matter have never turned in a receipt for reimbursement of any kind. They've donated their time, mileage, fuel and other resources, thus allowing the Foundation to donate 98 cents of every dollar contributed to us to our recipients.

After the reunion, the walkways at the VUMMF were redone with beautiful pavers.








What Happened To The Swift Officer's Association (SOA)?

On December 30, 1981 Bob Elder, then treasurer of the SOA, wrote to the Vietnam Veterans Memorial Fund (in part) -

"I am enclosing a contribution in the amount of \$791.02 for the Vietnam Veterans Memorial Fund. [this was all the money in the organization and it was disbanded]

Over the years we have accumulated some money and always intended to create or contribute to a memorial for those officers and men who lost their lives while serving on Swift Boats. Your organization is a fitting memorial to their service and their sacrifice."

This year's Veterans Day weekend was extra special for me because not only was it my birthday (11-11) but I was able to join other Swifties and participate with a bigger band of brothers in a collective Vietnam Welcome Home celebration in Washington, D.C. I have already posted some images of the celebration and parade on the MyFamily web site and I'll also be sending them to Jim Deal so that he can post them on our web site.

Although our group numbered less than fifteen, I felt the presence of not only the twenty-five to thirty Swifties that I had hoped would join us, but I must tell you that our Swift Boat Honor Crew took their position behind the SBSA Welcome Home banner. A memorial wreath, with a ribbon that read "Swift Boat Honor Crew" was placed on the front grill of Tony Snesko's Jeep. In the Jeep was "LATCH," Admiral Hoffmann, who proudly waved a flag staff that carried our colors, the South Vietnamese flag and the POW/MIA flag. Charlie Lloyd PCF-4 Skipper and Billy Alford (PCF-52) also rode in the Jeep.

Our parade slot was toward the tail end, nonetheless, we received a number of good cheers and A"Thank Yous" from the crowd along the parade route. As we approached the review stand, The MC called out our group by name and approached Terry Boone for comment. Terry announced that CTF-115, Adm. Roy F. Hoffmann was in the Jeep, which drew more applause and salutes from the veterans present. Our group stopped in front of the review stand and Ken Briggs called us to attention, facing the review stand and then ordered us to a hand salute.

One of the most memorable parade events for me was when an old salty Boatswains mate approached the Jeep off it's starboard bow and proudly standing at attention, piped the Admiral's arrival. Admiral Hoffmann was smiling from ear to ear.

We broke ranks at the end of the parade route and gathered by the SBSA Float for a group picture. We then proceeded down to The Wall to place the wreath in memory of our Honor Crew. We saluted our brothers and bid them a warm Welcome Home.

Virgil Erwin, SBSA's Newest Board Member and Vice President Reports Some Good-To-Know Experience

[written September 7, 2007] Got home last night, Tuesday, a day early. I thought I was going to write an interesting journal of a great 30 mile hike by a 64 year old Swift Boat Sailor with my boys, Chris, 30, Bret 23, both strong hockey players. Instead, this reads like a medical synopsis. Feeling better today but my legs still hurt.

<u>Friday</u> - Bret, Chris and I arrived in Yosemite's Cury Village at midnight. Chris' flight from Denver was six hours late. We spent two hours getting our backpacks organized and then not more than four and half hours sleep.



<u>Saturday</u> – 8 AM, Yosemite Valley to Toulumne Meadows via backpackers bus I started hiking with a 40 pound backpack.

We started out at 9,000' climbed up to 10,000' and back down to 9,500' 7 miles in six hours. Slow goin'.

80 degrees. Drank one liter of water, constant dry mouth.

Shortness of breath. Stomach cramps started when we stopped hiking. Ate one apple. Skipped dinner, no appetite. Slept 14 hours (6 PM to 8 AM)

<u>Sunday</u> - Chris and Bret put my stove, lantern and other heavy items into their packs

Hiked from 9,500' to 8,000' 7 miles in five hours. Lots of up and down terrain. (I hate the up part)

85 to 90 degrees. Drank two liters of water, dry mouth, felt dizzy at times Ate a small can of tuna at noon

All the rivers are dry. Passed by Sun Rise High Sierra Camp. They wouldn't give us water due to severe drought. Found a small spring three inches deep just as we all ran out of water. Filled our camelbacks and disinfected with iodine pills. Shortness of breath all day, stomach cramps in the evening.

No appetite. Forced myself to eat four spoonfuls of chicken and rice

<u>Monday</u> - Chris and Bret took more weight from my pack. Bret (Marine) is as strong as a pack mule.

Hiked from 8,000' to 4,000' (Yosemite Valley) 16 miles (poor judgment)

90 to 95 degrees, little shade. Drank the last two liters of my water. Found another spring, thank God and disinfected with iodine.

Felt faint sometimes, losing my balance, knees killing me going down steep granite stair-step switch-backs, dry cotton mouth. Chris said I was slurring my words, like I was drunk.

Ran out of water again and refilled from a pool at the top of Vernal Falls. Waded in with all my clothes to cool off.

Ate a small can of tuna at noon

Bob Shirley Embarks On His Last Patrol By Raul Herrera

Last night, nine Swifties attended the Memorial Service for Bob. It was quite moving. It began with a Buddhist Service. The rites are conducted as expressions of respect and gratitude to the deceased for the blessings and traditions left to us. Bhuddhist memorial rites are held in grateful memory of the deceased. The room was packed with Vietnamese family and friends, all chanting prayers as part of the service.

Following this service we were invited by Kim Anh and her children to address the guests. On behalf of all the members of the SBSA. I extended our most sincere condolences. Due to the majority of the guests present not being able to understand English, an interpreter made a beautiful attempt to convey my remarks. I had a number of emails from SBSA members that I wanted to read, however the interpretation effort made it almost impossible. I was able to read Major Ivan Consiglio's words of sympathy to the family. The group of Swifties stepped forward and faced Bob Shirley. Joe Lavoie then called us to attention and hand salute while he piped Bob Shirley aboard for his Last Patrol.

I then presented Kim Anh a framed photo of Bob, the one that shows him at the helm. I also gave the same photo to the three children. Thomas Shirley had found Bob's tiny gold PCF pin and had it place on Bob's left lapel. I also presented similar pins to Kim Anh and to Thomas, Jennifer and Michael.

Following the Memorial Service, we all went to Houston's, an outstanding steak restaurant. Before dinner, we raised out glasses and made a toast to Bob's memory.

This morning, we went to the funeral home to say our last good-bye's. Thomas asked four Swifties to assist in taking the casket to the hearse. At the DFW National Cemetery, we were surprised to learn that Col. Ken Cordier (former POW) had learned of Bob's passing and he made it a point to join us. He assisted in taking the casket from the hearse to the kiosk. Joe Lavoie once again piped Bob "Axelrod" Shirley along.

The final ceremony was very emotional. An active-duty Navy and Army team folded the flag and presented it to Jo Lavoie who in turn had the honor of presenting the flag to Kim Anh and family on behalf the Commander in Chief, the Chief of Naval Operations and the Swift Boat Sailors Association. The DFW Honor Guard (a group of mostly Vietnam Veterans) provide the three-man rifle team salute and one Marine-uniformed veteran bugler stood up above on high ground behind the rifle team. After the rifle salute, we all stood at attention with hand salute while Taps was sounded. After Taps, one of the Honor Guard members presented three spent shells to Kim Anh. They represented Duty, Honor, and Country. Thomas Shirley then expressed his final thoughts on his father. His remarks left no one present with dry eyes.

I want to thank all of the SBSA members that attended the service. Your presence warmed the hearts of the family. Special thanks to Col. Cordier and to Tom Wright for having his brother attend the service in his absence. "Bravo Zulu"

Reached the walk-in camp next to Upper Pines on the Valley floor at 5 PM. Breathing worse, stomach cramps started at 6 PM, threw up 9 times in one hour

Went to the Yosemite urgent care clinic at 9 PM at the insistence of Bret and Chris, Glad I did.

Blood pressure: 145/86

Pulse, EKG and Chest X-Ray were taken but don't know the results

O2: 98 - 97 (good)

White cell count: 218 (Bad, normal is 90)

IV: two liters + sedative + anti-biotic (sedative was great!)

Advised to leave Yosemite for lower altitude and check-in to doctor in San Diego

Advised not to do this hike again. Doctor said I was a dumb #%(& , I said I was a Swift Boat Sailor. She said, "Figures."

Discharged at 11:30 PM (wonder what this cost?)

Tuesday - Chris drove me home to San Diego and then flew back to Denver.

Wednesday - Went to Scripps Clinic. Dr Lin said he has had this same experience. Said heat exhaustion and altitude sickness impaired his judgment. He said 16 miles on a hot day was poor judgment.

Blood pressure: 120/80 (perfect)

Weight: lost 11 pounds

Dr. Lin said no exercise for a week. That's OK with me.

I'm still alive, cancel the 21 gun salute, or is 7 for dumb #%/& -?

Ed. Note: There are other directors and officers who will carefully watch Virg to see if this condition worsens!

This morning the CNO appeared before Spec Warfare members adjacent to the Memorial with the Wall and Boats in the background. The purpose of the visit was to present a Silver Star and 4 Bronze Stars to Seals for heroic actions in Iraq.

The Vietnam Unit Memorial is becoming the site of choice for many ceremonies. The new CJCS knows how to pick 'em.

Dagwood was talking to Blondie, "I had a dream last night where I was climbing a giant hot fudge sundae and there were cherries on top as big as bowling balls.... then it got weird."

The SBSA has formed a committee where Swifties can go for information about disability claims and medical care from the Department of Veterans Affairs. Where it got weird is labeling the committee members as VA reps. Actually, none of the committee members represent the VA. More properly, some of us are service officers for various veterans organizations and some of us just have a lot of knowledge about the disability claims process.

When you have to go to court you are always well advised to have an attorney and none of us would perform surgery on our own bodies. When one approaches the VA, which is the second largest of the federal executive departments (only the Defense Department is larger) having a service officer in your corner is the way to go.

Service Officers all work for the veterans and without cost. They range all over the map in competence, knowledge and skillfulness. Every veterans organization, and most especially, the American Legion, Disabled American Veterans, Fleet Reserve Association and Veterans of Foreign Wars have post service officers. If you live at the end of the known world, such as Bonners Ferry, Idaho on the Canadian Border, that post service officer may be your only choice.

Almost every county employs a veteran service officer (VSO). Here in my county, the second largest in Idaho, we have two full time VSO's. The next county north of us has a county VSO that works half a day every day. North of them in Bonner's Ferry, their VSO works half a day once a week.

Every state has state VSO's. These state VSO's are often found in the state capitol at the Department of Veteran Services, in the state veterans homes and in the VA Regional Office for that state.

All of the big veterans organizations have national service officers. The Disabled American Veterans employs 280 National Service Officers stationed at the VA Regional Offices where disability claims are adjudicated. The DAV is the only organization that has VSO's in every VA Regional Office.

Dagwood was talking...

When selecting a veteran service officer to assist you in filing a claim, my rule of thumb is that full-time, employed, service officers that are certified by the VA are your best choice. Such people have on-line access to VA forms, your VA records and attend training courses.

Your phone book is an excellent start in locating a VSO. Local veterans posts are good starting points. The local VA Medical Center will often have DAV or State or Departmental Service Officers. Your VSO should walk you through your military service asking about broken bones, hearing, injuries, sicknesses, wounds, and work experience. He should ask about current health. A Vietnam veteran with Prostate Cancer or Adult onset Type II Diabetes is automatically presumptive as being caused by Agent Orange.

You should put in your claim for every thing that happened to you. More on that in the next column. Your claim starts when the date time stamp is put on it in the VA Regional Office Mail Room. All payments are retroactive to that date.

The HALO EFFECT: Because some of us seem quite knowledgeable about some aspects of the VA claims process it is easy to think that we are experts in everything. There are so many benefits available to veterans and much fine print in the explanation that few people really know it all. The VA Committee members are here to offer what advice they can and guide you to the right place.

One of the committee members asked me to respond to a lady about DIC, which is Dependents Indemnity Compensation paid to widows of veterans who have died of service connected disability. I was surprised when he said he didn't know anything about it. His posts on VA matters have always been very sharp. It just so happened that I had just written an article for a military officers newsletter on that very subject. However, when the lady called, it wasn't so simple. She was having a terrible time qualifying for the payments. There are often no simple answers, but getting someone in touch with a good VSO is a big step in the right direction.

In the last month, I have received requests from four different Swifties on very complex questions. When there is not an immediate answer, it is because it is so difficult to even begin to answer that it is necessary to consult with professional VSO's in order to begin to figure out how to answer the inquiry. We won't blow anyone off. We will try to assist to the best of our ability.

My particular background is going on ten years as a DAV Chapter Commander and Adjutant and having been a DAV State Commander. I have attended state and DAV service officer schools and have access to county and national service officers.


