## Who saved my life?

From the Guestbook on the SBSA web site: "May 9th 2010 10:07:12 PM Name: Senyint Chim Current Location: San Diego, CA Military/Location/Dates:20 km north of Tan Chau, VN into Cambodia on either PCF91 and PCF94 SBSA Member?Unknown Comments:I was a 20 years old boy who rescued from the Khmer Rouge, VC, and NVA from Peam Chor South of Neak Leung, Cambodia on May 10th, 1970 by the PCF 91 and PCF 94. I would like to find out who were the commanding officers, officers, and sailors on those two boats on the day "Senyint Chin followed up with email to SBSA"

#### in October 2010 "Who saved my life?"

Virg Erwin met Senyint on 13 November 2010. He said there is a Swift Boat crew who are his heroes and he has spent years trying to find them. He asked for Virg 's help. Senyint is a Cambodian refugee and

them. He asked for Virg 's help. Senyint is a Cambodian refugee and now a US Citizen, a high school algebra teacher in San Diego. In 1970 the Viet Cong had dominate military control of Cambodia. "It was their safe haven during the day," Senyint says. "At night they ferried their supplies and men on the Bassac River into South Vietnam. And they were recruiting Cambodians to serve their purposes. If asked, there was no choice. "To avoid being forced to join the Viet Cong, I told the local VC leader in my village that I could be of more use because of my English language ability than if they sent me to shoot Americans. He agreed." In April of that year, Senyint witnessed the Viet Cong sink a Cambodian river patrol boat. "I don't know if the crew was killed, but that made me angry," Senyint said. He got permission from the local VC leader to travel to Phnom Penh. "I made up a story, said I was going to visit my sister who was sick. He gave me permission, but told me I had to return within seven days. " Senyint traveled to Phnom Penh, passing through many VC check points with a note from the VC leader. Senyint reported the patrol boat sinking to Cambodian government officials and military officers. It is hard to imagine Cambodia allowing VC checkpoints in their own country, but they did. The US Navy had evidence of this activity. The CIA



didn 't believe it was true. The VC discovered the real purpose of Senyint 's visit from informants. Senyint 's friends, even those working for the Khmer Rouge, told him that the VC had orders to kill him, to eliminate a witness. At constant urging from friends, Senyint was trying to escape. He was sleeping at friends homes, in a different home each night for a week. Senyint taught English and math. He knew the VC would only kill him in secret. The VC didn 't want the villagers to know they were after a school teacher, but of course the villagers did. On 8 May he placed a slate from his school room on the thatched roof of his home which was on the bank of the Bassac River, and in chalk, spelled out, " | am Cambodian. I have SOMETHING for you. I WANT TO GO WITH YOU. " He knew the VC would never see this message—they had no airplanes in that area. Senyint said Army Hueys were flying overhead all the time and hoped one would see his message. One did and reported it. But still no one came and there was no clearing nearby for a helicopter to land. On 10 May, 1970 he waved his chalkboard sign at two Swift Boats on the Bassac River. "And at just that time, a friend standing with me said, 'There are two VC standing about five meters behind you with guns. They want to talk to you. 'I knew they were ready to take me into the woods. "But I didn't turn around, I didn't look back. If I had, I would have lost all my courage. And the VC didn 't shoot me because there were these two Swift Boats with twin fiftycaliber machines guns pointed in our direction. I later learned the VC were afraid of shooting, afraid of starting a gunfight with the Swift Boats. Someone on one of the Swift Boats called over their loudspeaker and said, 'Swim out to us.' I jumped into the river. I was a weak swimmer. A sailor dove off a Swift Boat into the river to help me. " "I was there," George Allen Nelson writes, a Quartermaster Second Class in 1970 aboard PCF 56. "I saw a man on the river bank with a chalk board. I asked my Vietnamese trainee what it said. He said, 'I don't know Nellie, it is in English.' "I looked at it again. It said Help me. LT (jg) Howze, skipper of the Swift Boat, wanted to go in with the boat, but I said this looks like a trap as I had been involved in one before where an officer had been hurt bad, so I yelled for him to swim out. He gladly jumped in, but he couldn 't swim, so I asked our best swimmer to help him to the [bow] net. (continued on the next page)

He was cold so I gave him one of my shirts and we spoke. He said he had learned English from a European missionary and had information to help save his people from the VC who were taking their young men and would take him soon. "They picked me up," Senyint said, "and delivered me to a NILO (Naval Intelligence Liaison Officer). "We took him to an Intel boat," George wrote, "where we heard he gave information which helped greatly. "Senyint and George talked recently, for the first time in forty years. "I remember you had a bad eye," George said. "That told me," Senyint said, "this man is real. I do have a bad eye, a crossed eye. He was



there! " "Do you still have that shirt I gave you? " "Are you kidding? I wouldn't save a shirt for forty years." And then they both laughed. " An admiral promised to bring me to the US if I would work for them." Senyint started working for naval intelligence and going back into Cambodia on covert missions to help his country and his village friends. His stories are like listening to Ian Flemming's James Bond stories, but unlike fictional movies. Villagers so respected his mother, that they did not divulge his activity, for fear she would be harmed as a reprisal by the VC. One mission was just to take his mother out of the village. She didn't want to go, but with pleading, she left her home. I have the impression that the two VC who were tasked with killing Senyint did not survive the war. Senyint 's story is confirmed by a retired NILO, Larry Serra, who was in Vietnam at the time, reporting to Admiral Zumwalt and to Captain Rex Rectanus. Earl F. "Rex" Rectanus retired as a Vice Admiral, Larry knew all the players in all these operations, and so much more. "We called him, 'Sinjin,' Larry said. Larry published his experience in a book titled NILO Ha Tien, but as a novel for obvious reasons. Sinjin talked about his covert work for naval intelligence. "They gave me old army jackets and lots of cigarettes and I pretended to be a "smuggler," selling these items on the Cambodian black market which was my cover story. And from there collected information I was tasked to get." After a year of this activity, his mother convinced him to leave Cambodia for good. She worried his luck was running out. "After I did that for year, the US Embassy said the admiral 's promise was illegal. So Jack, my NILO controller, personally sponsored my opportunity to become a US citizen by bringing me to Camp Pendleton with the excuse of putting me through special ops training. He even let me live in his home in San Diego. Fortunately, the Navy never asked me to go back to Cambodia during the war. " That Swift Boat crew saved my life, "Sinjin said. "I've spent years trying to find that Swift Boat crew, to thank them. I'm going to the Swift Boat reunion in San Antonio next May, to say thank you for saving my life."

"We went for our Country," George writes, "and our beliefs as Americans and this person [Senyint] is why we are still proud we did our job! "Senyint talked by phone a week ago to Clayton Howze, the skipper of PCF 56. "He's coming to the reunion," Senyint said with a smile, "to meet again." Senyint is just barely five feet tall. He has round framed glasses for his crossed eye, soft features, a clear voice and a gentle smile. Senyint 's mother was killed by the VC in 1978.

## Veterans' Medallion Available for Order New Option for Marking Veterans' Graves in Private Cemeteries

WASHINGTON (June 29, 2010) - Secretary of Veterans Affairs Eric Shinseki announced today that the Department of Veterans Affairs (VA) is offering bronze medallions to attach to existing, privately purchased headstones or markers, signifying a deceased's status as a Veteran.

"For Veterans not buried in a national or state Veterans cemetery, or those without a government grave marker, VA is pleased to offer this option that highlights their service and sacrifices for our country," said Secretary Shinseki.

The new item can be furnished instead of a traditional government headstone or marker for Veterans whose death occurred on or after Nov. 1, 1990, and whose grave in a private cemetery is marked with a privately purchased headstone or



New Medallion

Under federal law, eligible Veterans buried in a private cemetery are entitled to either a government-furnished grave marker or the new medallion, but not both. Veterans buried in a national or state Veterans cemetery will receive a government headstone or marker of the standard design authorized at that cemetery. The medallion is available in three sizes: 5 inches, 3 inches and 1½ inches in width. Each bronze medallion features the image of a folded burial flag adorned with laurels and is inscribed with the word "Veteran" at the top and the branch of service at the bottom. Next of kin will receive the medallion, along with a kit that will allow the family or the staff of a private cemetery to affix the medallion to a headstone, grave marker, mausoleum or columbarium niche cover. More information about VA-furnished headstones, markers and medallions can be found at http://www.cem.va.gov/cem/hm/hmtype.asp. VA is currently developing an application form for ordering the medallion. Until it is available, applicants may use the form for ordering government headstones and markers, VA Form 40-1330. Instructions on how to apply for a medallion are found on the VA Web site at www.cem.va.gov/hm\_hm.asp. Veterans with a discharge issued under conditions other than dishonorable, their spouses and eligible dependent children can be buried in a VA national cemetery. Other burial benefits available for all eligible Veterans, regardless of whether they are buried in a national cemetery or a private cemetery, include a burial flag, a Presidential Memorial Certificate and a government headstone or grave marker.

The new medallions will be available only to Veterans buried in private cemeteries without a government headstone or marker. Families of eligible decedents may also order a memorial headstone or marker when remains are not available for interment.

VA operates 131 national cemeteries in 39 states and Puerto Rico and 33 soldiers' lots and monument sites. More than 3 million Americans, including Veterans of every war and conflict -- from the Revolutionary War to the current conflicts in Iraq and Afghanistan -- are buried in VA's national cemeteries on more than 19,000 acres. Information on VA burial benefits can be obtained from national cemetery offices, from the VA Web site on the Internet at www.cem.va.gov or by calling VA regional offices toll-free at 1-800-827-1000.

To establish a monument that brings honor and remembrance to those U.S. Navy and U.S. Coast Guard sailors who gave their lives at sea, in the air, and on coastal and inland waters during the Vietnam War (1960-1975).

To respectfully maintain the hallowed monument and grounds for thoughtful reflection on the sacrifices made by our military men and women during all wars, past and future, while protecting the freedoms we enjoy.


To serve as a bridge between sailors of the Vietnam War era and those on current active duty, such that the courage, dedication, and the sacrifices made by all are honorably and perpetually linked by the spirit of naval service.

The Viet Nam Unit Memorial at the Naval Amphibious Base Coronado continues to be a desirable and fitting location for many different types of military and memorial ceremonies. The Special Warfare Combat Crew classes (SWCC) hold their graduations at the Memorial. Change of Commands, retirements and special Memorial ceremonies are also held. A dedicated team of veterans continue to improve the grounds and provide support for the many uses of the area.

Some of you may wonder where your generous contributions to the VUMMF go. In the past 18 months, we have spent \$2400 to plant hedges which provide a better demarcation for the Memorial grounds. Government contracts have been cut back in scope, so we have stepped forward to make sure the Memorial continues to provide a fitting backdrop for these events. We spend \$1100 per year to replace the flags atop the Memorial Wall. The salt water environment and winds wear the flags rapidly. The Navy requires a one million dollar liability policy to be carried by the VUMMF at a cost of \$1050 annually. A post office box, fertilizer for the lawn and replacement of grounds equipment (lawnmower) are among other expenditures. Last year we spent over \$4000 to upgrade the web site.
