

Son Finds Parents Slain in South Dallas

Police are investigating the slayings of a husband and wife whose bodies were found Sunday in their Rylie home in southern Dallas.

The victims were identified as Ralph Singleton, 55, and Sherida Singleton, 53. Their 26-year-old son, who had returned after being away with friends for the weekend, found the couple about 4 p.m. in the 12000 block of Rim Rock Road, police said.

The husband and wife, described by neighbors as reserved but friendly, were found close together in the home and died of multiple wounds inflicted with a sharp instrument, said Sqt. Gary Kirkpatrick of the Dallas homicide unit.

"There was probably some sort of struggle," he said, adding that the slayings were probably not committed by a stranger. "It's a very violent, very bloody scene."

Witnesses on the guiet street lined with brick homes told police that they last saw the couple about midnight Friday, Sgt. Kirkpatrick said.

No weapon was found at the scene, and police did not immediately identify any suspects, but were seeking a second son, James Singleton, 21, who lives at the home, to determine whether he has any information about the deaths.

"We don't know where he is, at this point," Sgt. Kirkpatrick said.

Police found Mrs. Singleton's 1996 four-door black Chrysler Concord, which had been missing from the crime scene, in downtown Dallas early Monday morning.

Police, who released few details about the victims, were interviewing the elder son, Eric, who also lived at the home, to learn more about the family.

Witnesses said Eric Singleton ran from the home screaming before police arrived.

"He came out yelling," said Kasey Sexton, who was outside a friend's home a few houses away when she heard the commotion. She said the son hit himself on the head with a wireless phone and collapsed in the yard before returning inside.

"He was crying and yelling, 'They're dead, they're dead," she said.

She entered through the garage, looked inside the home and briefly saw the father, who was covered in blood from many wounds, police said.

"When you see [Mr. Singleton], you see ... [the killer] did it out of pure anger," she said.

People who live near the family's one-story home said Ralph and Sherida Singleton rarely interacted with neighbors. But on the occasions when they did, they were friendly and helpful, offering to run errands or fix household

Neighbors said Mr. Singleton worked for an insurance company. Mrs. Singleton was a homemaker. The pair often attended a local Catholic church, neighbors said.

"They're nice people, respectable," said Jerry Shiplett, who moved in next door about a year ago with his wife, Kristen.

Marcia Seaton, who had lived across the street for six years, said Mrs. Singleton had diabetes and often used a motorized cart to get around.

Neighbor Carol Bazan said Mrs. Singleton enjoyed arts and crafts as a hobby.

"She was a real nice lady," Ms. Bazan said. "She used to do stained-glass windows."

Mr. Singleton, who fought in Vietnam as a Navy seaman, was heavily involved with the Swift Boat Sailors Association Inc. Memorabilia from his war missions adorned the walls of the home, police said.

Richard Spelbring, who recently moved in two houses down, said he hadn't heard disturbances coming from the home. He said he chose the area because it seemed safe.

"This is unbelievable," he said. "This is not something that happens in your neighborhood."

Police reports dating back more than a decade show several incidents in which police were called to the home, officials said.

According to police reports, one of Mr. Singleton's sons was arrested in September 1996 in an assault at the home. Mr. Singleton told police at the time that he and the son, who is not identified in the report, had argued. The son struck Mr. Singleton on the left ear with his hand and knocked him to the ground, the report said.

The family also called police about criminal mischief and burglaries at the home. They made more than one call reporting a runaway from the home during the last 10 years. according to police records.

scale used for most military models. The Swift would be authentic, write to the manufacturer, either snail mail or ejust over 17 inches long. The hull would be solid basswood with a laser-cut superstructure, photo-etched brass and cast Britannia (white metal) fittings. It would be a kit, but in a size that would not strain the eyes.

The hull would be machine carved from a hand carved master. Typically 24 pieces are produced at a time. All of the laser work and metal casting is done on site. while the photo-etching is done off site. The actual production run would be based on demand.

A kit development project takes about 6-12 months to complete, depending on the complexity of the model. 
