#### From Viet refugee to Commander US Navy

A US military officer who fled Vietnam as a boy and was picked up by an American ship has visited the country in command of a destroyer. Born in the Vietnamese city of Hue, Commander Hung Ba Le and his family were picked up at sea in 1975 by a US naval ship in the closing days of the Vietnam war. His family settled in Virginia and he later became a US citizen, graduating in 1992 from the US Naval Academy. He returned to Vietnam in November with his ship, the guided missile destroyer USS Lassen, on a goodwill visit. 'This will be an incredible experience for me personally, to return to the land of my birth for the first time since I was a child,' Commander Le said in a Navy report. Commander Le called the visit 'a symbol of the friendship between our two nations.' The first Vietnamese-American to command a US naval ship, Commander Le took over the helm last year of the USS Lassen, which is part of the US 7th Fleet based in Yokosuka, Japan.

# "Gone, but never, never forgotten"





On 7 September, 1984, one of the worst peacetime tragedies occurred in Malta. This was the huge explosion on board the Armed Forces of Malta (AFM) patrol boat C-23 off Comino. The tragedy was the worst in the AFM's history, leaving five uniformed army personnel and two policemen dead. The explosion occurred while the soldiers were on duty dumping illegally manufactured fireworks, which had been seized only the day before, into the sea. It was a routine operation, and as was the custom, police officials were also in attendance. Such fireworks were usually dumped off Comino, or alternatively, off Filfla, near the limits of Dingli Cliffs. Warrant Officer Magro remembers the day of the tragedy as if it were yesterday. "I was a standing army officer at the time. On the day, I had been doing some maintenance work on one of our boats that was undergoing refurbishment. I was in the canteen having my lunch break, when at around 11.30am, someone made contact with the military saying that there had been a huge explosion on one of our boats somewhere off Comino. A helicopter which was patrolling the area at the time also confirmed this. It is difficult to describe all the emotions and feelings that rushed through my mind. Upon hearing the news, a number of us quickly set off on one of our standard boats to check the situation." Pausing to recall what exactly happened next, Warrant Officer Magro, years after the tragedy, still struggles for words. "From afar we could immediately tell that the situation was bad. However, the negative effects of the explosion hit us when we were in close proximity to the vessel. Parts of the sea were covered all over with gun powder. With heavy hearts we could do nothing but begin our search for the victims. To make matters worse, a few days before the accident, someone was caught illegally dumping large chunks of frozen meat. Try and imagine our discomfort, for every time we met a chunk of meat, we thought it was part of a dismembered body." It did not take long for the nightmare to become reality. "The first corpse we came across was burnt so badly by the blast that we struggled to identify who exactly it was.". The tragedy was the worst in the AFM's history, leaving five uniformed army personnel and two policemen dead. Bombardier Joseph Pace, 36, Gunner William Simpson, 36, Private Anthony Vella, 20, Police Sergeant Saviour Muscat, 30 and Police Constable Joseph Hare, 24, perished in the violent explosion, together with Bombardier Francis Borg, 36 and 27-year old Private Anthony Farrugia of Zeitun, whose remains were never found. ## **Veterans' Medallion Available for Order** *New Option for Marking Veterans' Graves in Private Cemeteries*

WASHINGTON (June 29, 2010) - Secretary of Veterans Affairs Eric Shinseki announced today that the Department of Veterans Affairs (VA) is offering bronze medallions to attach to existing, privately purchased headstones or markers, signifying a deceased's status as a Veteran.

"For Veterans not buried in a national or state Veterans cemetery, or those without a government grave marker, VA is pleased to offer this option that highlights their service and sacrifices for our country," said Secretary Shinseki.

The new item can be furnished instead of a traditional government headstone or marker for Veterans whose death occurred on or after Nov. 1, 1990, and whose grave in a private cemetery is marked with a privately purchased headstone or



**New Medallion** 

Under federal law, eligible Veterans buried in a private cemetery are entitled to either a government-furnished grave marker or the new medallion, but not both. Veterans buried in a national or state Veterans cemetery will receive a government headstone or marker of the standard design authorized at that cemetery. The medallion is available in three sizes: 5 inches, 3 inches and 1½ inches in width. Each bronze medallion features the image of a folded burial flag adorned with laurels and is inscribed with the word "Veteran" at the top and the branch of service at the bottom. Next of kin will receive the medallion, along with a kit that will allow the family or the staff of a private cemetery to affix the medallion to a headstone, grave marker, mausoleum or columbarium niche cover. More information about VA-furnished headstones, markers and medallions can be found at http://www.cem.va.gov/cem/hm/hmtype.asp. VA is currently developing an application form for ordering the medallion. Until it is available, applicants may use the form for ordering government headstones and markers, VA Form 40-1330. Instructions on how to apply for a medallion are found on the VA Web site at www.cem.va.gov/hm\_hm.asp. Veterans with a discharge issued under conditions other than dishonorable, their spouses and eligible dependent children can be buried in a VA national cemetery. Other burial benefits available for all eligible Veterans, regardless of whether they are buried in a national cemetery or a private cemetery, include a burial flag, a Presidential Memorial Certificate and a government headstone or grave marker.

The new medallions will be available only to Veterans buried in private cemeteries without a government headstone or marker. Families of eligible decedents may also order a memorial headstone or marker when remains are not available for interment.

VA operates 131 national cemeteries in 39 states and Puerto Rico and 33 soldiers' lots and monument sites. More than 3 million Americans, including Veterans of every war and conflict -- from the Revolutionary War to the current conflicts in Iraq and Afghanistan -- are buried in VA's national cemeteries on more than 19,000 acres. Information on VA burial benefits can be obtained from national cemetery offices, from the VA Web site on the Internet at www.cem.va.gov or by calling VA regional offices toll-free at 1-800-827-1000.

#### The Return of a Long Lost Navy Sword

This month three Navy Swift Boat veterans arranged for the return of a long lost family treasure, a U.S. Navy officer's sword, to the descendants of its original owner. Retired Navy Captain Stephen Morrison found the sword in a Seattle pawn shop in 1982. He had recently been promoted to Commander and as an Executive Officer he needed a sword for ceremonial purposes. The sword was obviously a U.S. Navy design but with a slightly curved blade indicating that it was much older than the current straight-bladed model. The quality of the workmanship was very high on both the sword and its scabbard with only minor wear to show for many years of service. The only clue to its original owner was the name "T.A. Stareck" engraved on the blade.

Stephen retired from the Navy in 1992 and he retired the sword to the wall of his home office. It remained there until 2009 when he donated it to retired CWO2 Boatswain Joe La Voie. Joe had recently retired from his civilian job as a surveyor and was volunteering his services at the Tahoma National Veterans Cemetery in Auburn, Washington. Each day in full dress Navy uniform Joe was conducting up to twenty veteran funerals. Stephen's sword was the perfect compliment to Joe's full dress uniform.


Although Joe greatly valued the sword he couldn't help thinking of its original owner and the possibility of returning it to one of his descendents. He searched for information on T. A. Stareck but could only find one reference on the Internet. That was for a warrant officer who had served on the USS Panther, AD-6 an auxiliary ship that sailed around the world with the Great White Fleet in 1907-09. Beyond that one reference the history of the sword remained a mystery - until last month.

Stephen and Joe have lunch once a month with Bill Rogers, Monty Mantonya and other Swift Boat veterans. By coincidence Bill had been searching for the owner of a civil war saber using special genealogy software. He offered to search for the owner of Joe's sword. Using census records and other military records Bill discovered a nine-year-old boy, Thomas Anthony Stareck, who had immigrated to the US in 1886 and lived in Petersburg, Michigan. Census records from 1900, 1910, 1920 and 1930 traced Thomas' career in the US Navy from Hospitalman, Pharmacist and Chief Pharmacist to Lieutenant Commander. The 1910 census records revealed a wife, Harriett and later, in 1930, an adopted son, Anthony E. Unfortunately, social security records showed that the son died in California in 1993 and the trail went cold. That is until February 13th when Thomas E's wife, Anna died in Waukashaw, Wisconsin. Her obituary notice listed a son, Thomas R. Stareck and a daughter Kathryn. A telephone directory search soon led Bill to Thomas R. living in New Berlin, Wisconsin.

Joe called Tom Stareck and explained the situation with the sword. Tom was amazed and delighted. Apparently his father had fallen on hard times in California and had sold the sword. The family was distressed to lose it and had tried to find it and recover it but without success. They assumed that it was gone forever.

This week Joe, Stephen and Bill took a final photo of the sword and shipped it overnight to Tom and Kathryn in Wisconsin. They soon received a photo of the Stareck grandchildren and great grandchildren holding the treasured family heir-loom. This week Joe was rewarded for his efforts with his own brand new Navy officer's sword complete with gold plated scabbard and sword knot compliments of Bill, Stephen and Monty. This one he will never have




SBSA Board of Directors Meeting, July 17, 2010 at the Crown Plaza Riverwalk Hotel, San Antonio, Texas
